Dear Thermalito Families:

Here is another update on the reopening status of our campuses for in-person instruction.

Butte County remains in the Red Tier, so our plan to reopen our campuses to targeted groups of students on October 19 is a go. The students in these groups have been contacted directly by school staff with their scheduled day and time of support services. All students, including those with support services will be expected to complete their distance learning assignments during this period between October 19 and November 9.

We continue to be on schedule for a full A/B cohort start at the beginning of our second trimester on November 9. Students will be divided into an A or B cohort with each cohort coming to campus for in-person instruction two days per week. The graphics below give an overview of the schedules. Our staff is working on finalizing the start and end times of each day and the student lists for A/B cohorts, and we will share that information soon.

Our TLC Preschool will also be reopening its campus on November 9 to students in a modified format. The staff will be reaching out to families in their program to share more specific information.

To recap previous communications, all on-campus instruction will require the district to implement the California Department of Public Health's guidelines for reopening schools. Students and adults on campuses will be required to adhere to the safety guidelines including, but not limited to, wearing a mask and maintaining social distancing during their time on campuses. For everyone's safety, we ask that we do not have unannounced visitors on campus. If you need to be on campus, check into the main office and they will assist you with your business.

We understand that in-person, on campus instruction may not suit every family, so we have other options available. We will offer a 100% Distance Learning option where students will access their education online in a completely off-campus environment. We also offer an Independent Study Program that provides an online

independent study environment for grades 3-8 with some in-person support. For more information regarding independent study, please visit this <u>link</u>.

We will send out a survey soon that we need parents and guardians to complete to choose the instructional model that meets the needs of their students for the trimester beginning November 9. That survey will include finalized details of the A/B model and 100% Distance Learning model so that parents and guardians can make a fully informed decision and we can be properly staffed on November 9.

If you have used student transportation in the past and you know that your student will need district transportation beginning November 9, please use this link to the <u>Transportation Request Form</u> on our website to help us ensure that we have accurate information. All students riding the bus will be required to wear a face covering. Please visit our website and social media accounts for the latest information regarding school information.
