## A description of how the development of the plan was influenced by community input.

Thermalito staff and community members suggested the following supplemental instruction utilizing tiered levels of support, universal, targeted, and intensive. Supports implemented will be provided for academics and social-emotional needs with attention given to providing an engaging learning experience within a positive school climate.

- The 2021 summer school data reflected that the targeted reading intervention program was a tremendous success. Parents and teachers suggested this dynamic reading program continue in 2022 and beyond with the addition of math fluency intervention.
- Community and staff suggestions were also made to extend instructional learning time to before and/or after school reading and math fluency interventions based on student learning needs.
- Additional classroom paraeducator support and training were suggested to help teachers with in-school reading and math interventions.
- Administration and staff suggested Universal Design for Learning (UDL) professional learning training for teachers and
  paraeducators. UDL is based on research in the learning sciences and will allow student choice through engagement and intentional
  teaching that will break down barriers to student learning.

# **ESSER III Expenditure Plan Instructions**

#### Introduction

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
  - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
